- 1. Latest Annual Income Tax Returns – filed and paid through the BIR Electronic Filing and Payment System (eFPS) in three (3) clear copies;
- 2. Business Tax Returns (six [6] months prior to the opening of bids [VAT or Percentage Tax]) – also, filed and paid through the BIR Electronic Filing and Payment System (eFPS) in three (3) clear copies; and
- 3. Four (4) Pieces Sample and one (1) cut away of the offered brand.

WHEREAS, on October 3, 2023, the BAC Secretariat has received the aforementioned additional requirements from Uni-field Enterprises Inc. which was endorsed to TWG for post-evaluation per Resolution No. 055, dated October 4, 2023;
