WHEREAS, the opening of bids was conducted on August 15, 2023 and only one (1) bidder bought the bid documents and submitted the eligibility documents and found to be as;

WHEREAS, the documents submitted by Up-Town Industrial Sales, Inc. was thoroughly reviewed by the Bids and Awards Committee (BAC) and was declared as complying and eligible to bid;

WHEREAS, having the participating bidder as complying and eligible to bid, the BAC has continued with the opening of its financial proposal which was pre-audited by COWD’s Internal Auditor:

WHEREAS, on the same date, a notice for post-evaluation was forwarded to Up-Town Industrial Sales, Inc. requiring to submit its Latest Annual Income Tax Returns and Business Tax Returns [six (6) months prior to the opening of bids] filed and paid through the BIR Electronic Filing and Payment Systems (EFPS), in three (3) copies within five (5) calendar days upon receipt of notice;

WHEREAS, on August 18, 2023, the BAC Secretariat has received the aforementioned additional requirements from Up-Town Industrial Sales, Inc. and was endorsed to TWG for post-evaluation as per BAC Resolution No. 046, dated August 22, 2023;

WHEREAS, on August 31, 2023, the BAC has received the evaluation result for Up-Town Industrial Sales, Inc., disclosing that it has met the technical specifications set by COWD, hence the proposal is responsive, per Technical Evaluation Sheet No. 2023-036, dated of the same date;



WHEREAS, further re-evaluation of the bid proposals submitted was conducted on September 1, 2023, and the BAC has severally moved and severally seconded to declare Up-Town Industrial Sales, Inc. as the bidder with the Single Calculated and Responsive Bid;

NOW, THEREFORE, WE, the members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a) To declare Up-Town Industrial Sales, Inc. as the bidder with the Single Calculated and Responsive Bid for the 1 Lot Supply and Delivery of B.I. Pipes of Various Sizes, per specifications, in the amount of ₱941,390.00 only;


