3. Notarized Omnibus Sworn Statement


WHEREAS, on March 21, 2023 the BAC has received the complete additional documentary requirements from Aja NRW Solutions, Inc.;

- b) To recommend for approval to the General Manager of the Cagayan de Oro City Water District the foregoing findings.




