WHEREAS, Cagayan de Oro City Water District invited prospective bidders to apply for eligibility and to bid for the specified project per specifications indicated in the Purchase Requisition:

WHEREAS, opening of bids was conducted on October 3, 2023 and two (2) bidders bought the bid documents and submitted the eligibility & technical documents and were found to be as:

WHEREAS, the Eligibility and Technical documents submitted by Metos Offshore, Inc. was thoroughly reviewed by the Bids and Awards Committee (BAC) and was declared as noncomplying & ineligible to bid due to non-submission of the following:

- 1. List of Agency's Personnel to be assigned to the contract with the following attachments: (3 Males and 3 Females):
 - a) Complete Qualification and Experience Data (Bio-Data/CV);
 - b) Barangay Certification of Good Moral Character;
 - c) Police/NBI Clearance;
 - d) Medical Certificate;
 - e) Certification of Training in housekeeping especially in hazardous waste handling by a duly licensed agency; and
 - f) COVID-19 vaccination card.
- 2. Certification stating that agency has a local office within Cagayan de Oro City;
- 3. Certificate of Good Standing:
 - PhilHealth (Submit the Latest Certification of Remittances for the last 3 months with certified true copies of invoice of payments for the last 12 months); and
 - PAG-IBIG (Submit the Latest Certification of Remittances for the last 3 months with certified true copies of invoice of payments for the last 12 months) submitted a printed email letter only.
- 4. Performance Certificate from the previous Client other than COWD.

WHEREAS, after Metos Offshore, Inc. was declared as non-complying and ineligible to bid, its financial envelope remained sealed and unopened and also signed by the BAC members for safekeeping.

WHEREAS, the Eligibility and Technical documents submitted by Hinex Janitorial & Allied Services was thoroughly reviewed by the BAC and was declared as Complying & Eligible to bid.

WHEREAS, having Hinex Janitorial & Allied Services as complying and eligible to bid, the BAC has continued with the opening of its financial proposals which was pre-audited by COWD's Internal Auditor;

WHEREAS, the BAC has declared Hinex Janitorial & Allied Services as the Single Calculated Bid and deemed it necessary to seek the assistance of the Technical Working Group (TWG) in the post evaluation of its bid documents;

WHEREAS, on October 4, 2023, a notice for post-evaluation was forwarded to Hinex Janitorial & Allied Services, requiring to submit the following additional requirements filed and paid through the BIR Electronic Filing and Payment System (eFPS) in three (3) clear copies within five (5) calendar days for post-qualification:

- 1. Latest Annual Income Tax Returns; and
- 2. Business Tax Returns (six [6] months prior to the opening of bids [VAT or Percentage Tax]).

WHEREAS, on October 6, 2023, the BAC Secretariat has received the aforementioned additional requirements from Hinex Janitorial & Allied Services which was endorsed to TWG for post-evaluation per Resolution No. 057, dated October 9, 2023;

WHEREAS, on October 18, 2023, the BAC has received the evaluation result of Hinex Janitorial & Allied Services, disclosing that it has met the technical specifications set by COWD, hence the proposal is responsive, per Technical Evaluation Sheet no. 2023-046, dated October 18, 2023;

WHEREAS, further re-evaluation of the bid proposals submitted was conducted on October 19, 2023, and the Bids and Awards Committee has severally moved and severally seconded to declare Hinex Janitorial & Allied Services as the bidder with the Single Calculated and Responsive Bid;

NOW, THEREFORE, WE, the members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:
